(OTCBB:FBPI) has declared a quarterly cash dividend of \$0.155 per share, payable to stockholders of record as of March 5, 2018. The dividend will be paid on or about March 15, 2018. The annual dividend rate on this quarterly declaration is unchanged from the preceding quarter and results in an annualized dividend yield of 2.95% based on the \$21.05 share price for the last reported trade as of February 22, 2018.
